(hereinafter referred to as the 'Liget Boulder' climbing room), operated by the company Veszpremmé, at 8 Veszpremény, Veszpremény, also falls into the category of particularly dangerous (extreme) sports, and therefore social security does not cover the costs of any accidental injuries.

I, the undersigned (as User or legal representative) acknowledge/declare that:

There is a risk of serious injury or death during the activity;

I, as the person who voluntarily assumes the risk of sporting activity, bear the damage that is normally associated with that activity and which is part of the normal risk;

I enter and perform any activity in the room under my own/legal representative's responsibility.

By entering and signing this declaration, I have read and accept the Privacy Policy and the Rules of the "Liget Boulder" climbing room. The Privacy Policy is available at the reception desk and on our website: <https://ligetboulder.hu/>, while the Rules are posted at the reception desk of the climbing room.

The climbing gym and its operator are not responsible for any injuries or damages that do not result from the use of the equipment or devices provided by them, or for collisions with third parties (climbers or visitors);

After using the facility and leaving it, I cannot claim compensation for any physical/movement injuries, such as: sprains, lumbar sprains, etc., in the absence of an official accident report taken on the spot;

I am not entitled to claim damages for mental health problems against the climbing gym and its operator (such as: developing a fear of heights, anxiety symptoms, etc.);

I acknowledge that I will compensate the climbing gym and its operator for any damage caused by me without delay;

I acknowledge that in the event of intentional damage to or theft of equipment/equipment belonging to the climbing room and its operator, the climbing room and its operator - regardless of the amount - are entitled to file a police report for intentional endangerment of third parties, and are entitled to assert their claims through legal action;

I am fully familiar with the safe use of the equipment used in the climbing room;

I use the climbing area and its equipment at my own risk,

The Climbing Room and its operator are not responsible for any personal injury or property damage resulting from the use of the Climbing Room and its equipment;

The Climbing Room and its operator shall not be liable for any damage to property brought into the Climbing Room or left anywhere on the Climbing Room premises.

Smoking, open flames, littering and any dangerous activities are strictly forbidden in the climbing area. It is forbidden to use the climbing wall under the influence of drugs, alcohol and medicines (!);

I declare that I have no illness, medical condition or other infection affecting my ability to participate in sport, that I am not under the influence of alcohol or any other intoxicating substance and that my fitness to participate in sport has not been in doubt recently. I acknowledge that the use of magnesia is permitted in the Hall, which has a negative effect on air quality. Should this cause me health problems, I am obliged to reduce the duration of my visits and to leave the Hall in good time.

Any problems with the wall, handholds, tools, equipment or the behaviour of others must be reported immediately to the operating staff;

The Climbing Room and its operator are not liable for any damage caused by me unlawfully, intentionally or through gross negligence or gross negligence (including, without limitation, while under the influence of alcohol, drugs or intoxicating substances).

I acknowledge that if my behaviour/activity offends or disturbs the persons or activities of others present/using the room, the operator or its employees may send me out of the room and refuse me re-entry.

I acknowledge and agree that the operator, or a third party acting on behalf of the operator, may take photographs of me or the person I represent on the premises of the climbing gym for marketing purposes and publish them on the website of the climbing gym or on social media.
